Applications are invited from eligible Indian nationals for the post of one Junior Research Fellow under a project entitled “Reprofiling of molecules for inhibition of aggregation of  $\alpha$ -synuclein in vitro and in cell model of Parkinson’s disease” sponsored by Science and Engineering Research Board (SERB), GoI, New Delhi [GP-435] under Dr. Ipsita Roy, Associate Professor, Department of Biotechnology, NIPER, SAS Nagar. The position is purely temporary, initially for one year, which is extendable based on the performance of the candidate and is strictly co-terminus with the duration of the project.

- Essential qualifications:** M.Sc./M.S. (Pharm.)/M. Pharm. in Biochemistry/Microbiology/Biotechnology/Life Sciences. Documented research experience in protein analysis and characterization tools is desirable. Minimum CGPA of 6.75 (or 60% marks) for General category, 6.25 (or 55% marks) for SC/ST, 5.75 (or 50% marks) for physically handicapped (PH) candidates on a 10 point scale is required in the qualifying examination.
- Age Limit:** 28 years (age relaxation for SC/ST/PH is as per GoI rules. The candidates are required to attach valid proof for claiming relaxation as per the guidelines prescribed by the Government of India from time to time).
- Salary:** Rs. 31,000/- p.m. (+HRA, if applicable)
